# Trip to Jackson Hole, WY!

Saturday, February 28 to Saturday, March 7st 2015

The Jackson Hole Mountain Resort is a ski resort in Teton Village, Wyoming. Located 12 miles northwest of Jackson and due south of Grand Teton National Park in Teton County. With a vertical rise of 4,139 feet, 2,500 acres of inbounds terrain, and backcountry access, skiing Jackson Hole is an experience of a lifetime.

- **LODGING**: 7 nights lodging at one of two hotel choices
  - Snake River Lodge & Spa: As the premier destination choice in Jackson Hole, this breathtaking resort is conveniently located in Teton Village, steps from the base of the Jackson Hole Mountain Resort via a heated walkway.   - Alphelhof: A Bavarian style hotel right in the heart of Teton Village that has been around since the founding of the ski area. The closest hotel to the lifts, the Alpenhof is located next to the Aerial Tram and steps from the Bridger Gondola. Next door to the Snake River Lodge. - AIR: Choose from group air or no air (self booked air)
- <u>GROUP SHUTTLE BUS:</u> Round trip ground transportation airport to hotel. If you choose group air, you should elect for the group bus shuttle option. If you do not choose group air, we cannot guarantee the group rate and you should elect the self book shuttle option until flight times are confirmed.
- LIFT TICKETS: Choose from no lift tickets to 6 days of lifts at The Jackson Hole Ski Report, and Choose from one to two days of lifts at Grand Targhee ski resort.

#### I understand what the trip includes, as per this flyer AND:

- Double occupancy means the price is based on 2 people per room, and if you can not confirm a roommate or your roommate cancels, you may be charged a single room upcharge fee. Ultimately, You, not the trip chairperson is responsible for finding a roommate
- Westmoreland Ski Club membership is required for travel. \* Not a member? It's easy to join. For membership information, send a request for information to <a href="wscmembership@outlook.com">wscmembership@outlook.com</a> (\*membership requirement is waved for residence outside SW-PA where a \$35 fee applies)
- o Sign up and payments are only accepted on line via credit card.
- You are able to make TWO payments on line- your first payment is 50% of the amount owed, the second payment is your balance which is due by the trip FINAL PAYMENT DEADLINE 12/30/2014
- CANCELLATIONS: For purposes of this agreement, "air cost" is defined as all air transportation included in a reservation, and "land cost" is any and all other tour components, including but not limited to lodging, lift tickets, ground transportation, and other services. All cancellations must be received by our office in writing via email adaman@skitherockies.com and copy jgasior@wesco.com All cancellations after 11/21/2014 will be assessed a \$50 per person fee plus any non-recoverable air and land costs. Regardless of original payment method, all refunds will be made by company check and handling fees may apply.
  - o LODGING: No refund after Nov 21st and new reservations will be made based on availability.
  - o **AIR: No refund after Dec 30**. Ticketing occurs after final payment received on 12/30/2014 Once ticketed, name changes may incur a \$250 fee (as charged by the airline)
